NO.GP/39/MCG/102010/4742/V/Special Cell :- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in supersession of all the rules made in this behalf, the Governor of Gujarat hereby makes the following rules to provide for regulating recruitment to the post of Assistant Professor, Class I in the General State Service, in the subjects mentioned in the Annexure-I and Annexure-II at the Government Medical Colleges, attached Medical Hospitals and Institutions under the Commissionerate of Health, Medical Services and Medical Education and Research, Gujarat State, namely:-

1. These rules may be called the Assistant Professor, Class I, in the General State Service, in the subjects mentioned in the Annexure-I and Annexure-II at the Government Medical Colleges, attached Medical Hospitals and Institutions Recruitment Rules, 2017.

2. In these rules, unless the context otherwise require;

(i) "Medical candidate" means a candidate possessing the degree of M. B. B. S. and having registration under the State or Central Law pertaining to requirement of Medical Registration.

(ii) "Annexures" means annexures appended to these rules.

(iii) "Equivalent qualification" means the qualification as recognised by the Medical Council of India.

3. Appointment to the post of Assistant Professor, Class-I, in the General State Service, in the subjects mentioned in the Annexure-I and Annexure-II at the Government Medical Colleges, attached Medical Hospitals and Institutions under the Commissionerate of Health, Medical Services and Medical Education and Research, Gujarat State shall be made either, -

(a) by promotion of a person of proved merit and efficiency from amongst the persons who,-

(i) have worked for not less than eight years in the cadre of Tutor, Class II, in the General State Service, in concerned subject

at the Government Medical Colleges, attached Medical Hospitals and Institutions under the Commissionerate of Health, Medical Services and Medical Education and Research; Gujarat State;

(ii) possess the educational qualification prescribed in the clause (b) of rule 4 for direct selection; and

(iii) have passed the qualifying examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006:

Provided that, where the appointing authority is satisfied that a person having experience specified in sub-clause (i) above is not available for promotion and It is necessary in the public interest to fill up the post by promotion even of a person having experience for a lesser period; it may, for reasons to be recorded in writing, promote such person who possesses experience of a

period of not less than two-thirds of the period specified in sub-clause (i) above; or

(b) by direct selection.

4. To be eligible for appointment by direct selection to the post mentioned in rule 3, a candidate shall,-

(a) not be more than 43 years of age:

Provided that the upper age limit may be relaxed in favour of candidate who is already in the service of the Government of Gujarat in accordance with the provisions of the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967.

Provided further that, nothing contained in clause (b) of sub-rule (9) of rule 8 of the Gujarat Civil Services Classification and Recruitment Rules, 1967 shall be applicable in so far as relaxation of upper age limit as prescribed above is concerned;

(b) possess academic qualifications as specified in the annexure-I or annexure-II obtained from any of the University established or incorporated by or under the Central or a State

Act in India, or any other educational institution recognised as such or declared to be deemed as a University under section 3 of the University Grants Commission Act, 1956, or possess an equivalent qualification recognised by the Medical Council of India;

(c) possess atleast three years teaching experience as ^{Con} Resident / Registrar / Demonstrator or Tutor in the subject and one year senior resident in the subject as specified in the Annexures at recognised / approved / permitted Medical college as prescribed below:

(i) for the candidate possessing MD or MS or DNB degree in the subject as specified in the Annexures from Medical Council of India recognised Medical College or Institute and have three years teaching experience in the subject as Junior Resident in a recognised ^{mci} Government Medical Colleges attached Medical Hospitals or Institute in the concerned subject and one year teaching experience as Senior Resident after obtaining MD or

MS or DNB degree in the concerned subject in a Medical Council of India recognised Government Medical College, attached Medical Hospitals or Institute.

(ii) for the candidate possessing DNB degree in the subject as specified in the Annexure-I from other than Medical Council of India recognised Medical College or Institute and have three years teaching experience as Junior Resident in a recognised Government Medical Colleges attached Medical Hospitals or Institute in the concerned subjects after obtaining DNB degree and one year teaching experience as Senior Resident in the concerned subject in recognised Government Medical Colleges attached Medical Hospitals or Institute.

(iii) for the candidate possessing MBBS with M.Sc. (Medical) or M.Sc. with Ph.D. or M.Sc. with D.Sc. degree in the subject specified in the Annexure-I shall have three years teaching experience as Resident / Registrar / Demonstrator or Tutor in the concerned subject in a recognised Government

Medical Colleges attached Medical Hospitals or Institute and one year teaching experience as Senior Resident in the concerned subject in a recognised Government Medical Colleges attached Medical Hospitals or Institute.

(iv) for the candidate possessing MDS degree in any dental subject, shall have three years teaching experience as Resident / Registrar / Demonstrator or Tutor in dentistry department in a Medical Council of India recognised Medical College or Institute and one year teaching experience as Senior Resident in dentistry department in a Medical Council of India recognised Medical College attached Medical Hospitals or Institute.

(v) for the candidate possessing D.M./M.Ch./DNB degree in the subject as specified in the Annexure-II from Medical Council of India recognised Medical College or Institute and have three years teaching experience in the subject as Junior Resident in

the concerned subject in a recognised Medical College, attached Medical Hospitals or Institute.

(vi) for the candidate possessing DNB degree in the subject as specified in the Annexure-II from the other than Medical Council of India recognised Medical College or Institute and have three years teaching experience in the subject as Junior Resident in Medical Council of India recognised Medical College attached medical hospital or teaching institute after obtaining DNB degree. ↘

(c) possess the basic knowledge of computer application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967, and

(d) possess adequate knowledge of Gujarati or Hindi or both.

5. The candidate appointed by direct selection shall be on probation for a period of two years.

6. The candidate appointed by direct selection during his probation period, shall be required to pass the qualifying

examination for computer knowledge in accordance with the provisions of the Gujarat Civil Services Computer Competency Training and Examination Rules, 2006.

7. The candidate appointed by direct selection shall be required to pass the examination in Hindi or Gujarati or both in accordance with the rules prescribed by the Government.

8. The candidate appointed either by promotion or by direct selection shall be required to undergo such training and to pass such examination as may be prescribed by the Government.

9. The candidate appointed by direct selection shall be required to get himself registered in a State Medical Council or Dental Register or Indian Medical Council or Dental Register under the Indian Medical Council Act, 1956 or Dental Council Act, 1948 at the time of his application for direct selection, if he is not so registered.

10. The candidate appointed by direct selection shall be required to furnish a security and surety bond in such form, for

such amount and for such period as may be prescribed by the Government.



1. These rules may be called the Assistant Professor, Class I, in the General State Service, in the subjects mentioned in the Annexure-I and Annexure-II at the Government Medical Colleges, attached Medical Hospitals and Institutions Recruitment (Amendment) Rules, 2019.
2. In the Assistant Professor, Class I, in the General State Service in the subjects mentioned in the Annexure-I

and Annexure-II at the Government Medical Colleges,
attached Medical Hospitals and Institutions
Recruitment Rules 2017 (hereinafter referred to as the
"the said rules") in rule 2, after clause (iii), the
following clause shall be inserted,-

"(iv) "Senior Resident" means a candidate who is doing
his residency in the concerned Post-Graduate subject
after obtaining PG degree (MD/MS) and is below 40
 years of age."

3. In the said rules, in rules 4, in clause (c),-

(i) for the word "subject", the words "concerned subject"



- (iii) in sub-clause (iii) for the word "Resident" occurring after the words "three years teaching experience as", the words "Junior Resident" shall be substituted;
- (iv) in sub-clause (iv),—
- (a) for the word "Resident" occurring after the words "three years teaching experience as", the words "Junior Resident" shall be substituted;
- (b) for the words "dentistry department" occurs after the words "Senior Resident in", the words "dentistry department/dentistry subject" shall be substituted.
- (v) in sub-clause (v) and sub-clause (vi), for the words "Junior Resident", the words "Resident/Registrar/Demonstrator/Tutor" shall be substituted.

- (vi) in sub-clause (vi), after the words "obtaining DNB degree", the words "and shall undergo one additional year of senior residency or equivalent training or research job in a MCI recognised hospital/ institution" shall be added.

1. (i) These regulations may be called the "Minimum Qualifications for Teachers in Medical Institutions (Amendment) Regulations, 2019".
- (ii) They shall come into force from the date of their publication in the Official Gazette.

3. In the "Minimum Qualifications for Teachers in Medical Institutions Regulations, 1998", the following shall be added as clause 12 in Schedule I:-

The academic qualification for any new broad specialty or super specialty shall be the one shown at the time of notifying the new specialty in these Regulations. Persons appointed as teaching faculty during the transition period shall be entitled for promotion to the post of Associate Professor/Professor even after the transition period is over. However, once the intake capacity of the new specialty or super specialty reaches the number 100 in Medical Institutions falling within the ambit of the Indian Medical Council Act, 1956 and remains 100 or above for three consecutive academic years, the matter shall be reviewed by the Council whether to continue with the same academic qualifications or mandate that new appointments shall be made of persons with the required academic qualification of that specialty.
