**Order:-**

Considering the situation of Covid-19, the Government of India has declared notify disaster vide National Disaster Management Act. The Government of Gujarat has declared the Epidemic Disease, Covid-19 Regulation, 2020 on 13.03.2020. Presently, the number of indoor patients at General Hospital, Vyara are increasing day by day. The Non-Covid Patients are also admitted in hospital at Civil Hospital, Vyara. Considering the number of increased cases of Corona, it is necessary to increase more beds in the district for such patients; therefore, it is decided to declare Kalidas Hospital, Vyara as dedicated Covid Hospital and to make arrangement of total 100 beds at said hospital. The order is passed for appointment as under for the management of said hospital.

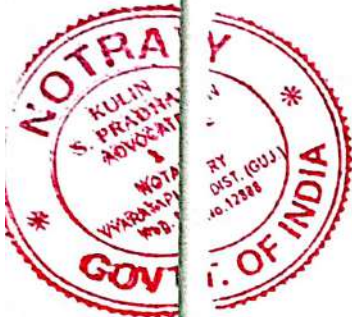
