

# **STARTING OF SIX MONTH'S CERTIFICATE COURSE IN GENERAL DENTISTRY GOVT.DENTAL COLLEGE AND HOSPITAL, AHMEDABAD**

## **Eligibility criteria and specifications for admission are as follows –**

1. BDS degree from any institute, recognized by Dental Council of India, New Delhi
2. Merit list would be prepared on the basis of marks secured by the candidate in Final year BDS.

## **Details of Certificate Course**

Total duration of the course would be of Six months.

Candidate would be trained clinically as follows.

1. Dept. of Conservative Dentistry and Endodontics – 2 months.
  2. Dept. of Prosthetic Dentistry – 2 months.
  3. Dept. of Oral and Maxillofacial Surgery -1month.
  4. Dept. of Periodontia – 1 month.
- No stipend would be paid to the Candidate during the entire Fellowship Program  
Candidates admitted for this Fellowship Program are not entitled to get any type of accommodation such as Hostel or Quarters .
  - Mode of admission would be twice in a year that is 1<sup>st</sup> January to 30<sup>th</sup> June and 1<sup>st</sup> July to 31<sup>st</sup> December every year.
  - Those getting admitted for the Batch starting from 1<sup>st</sup>January are required to complete the admission formalities by 15<sup>th</sup> December.
  - Those getting admitted for the Batch starting from 1<sup>st</sup> July are required to complete the admission formalities by 15<sup>th</sup> June.
  - Amount of Rs. One Lakh (non-refundable) to be paid by Demand Draft or through NEFT / RTGS as course fee in the RKS account, the details of which would be made available on college website.
  - DD should be drawn in favor of – **“Rogi Kalyan Samiti, Government Dental College and Hospital, Ahmedabad”**
  - Maximum 15 students would be allowed per batch as per merit list.

- After successful completion of the course, a certificate by the Institute would be awarded to the candidate.
- Interested candidates are informed to apply in prescribed format as per below mentioned schedule. Application form is available at Institute's website. Candidate shall report with all required documents to 'Student Section' of the Institute as per prescribed schedule.

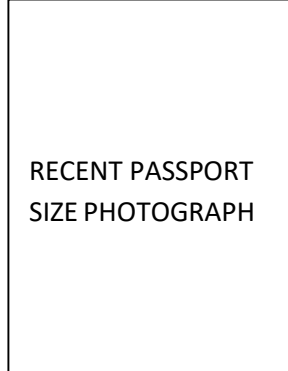
